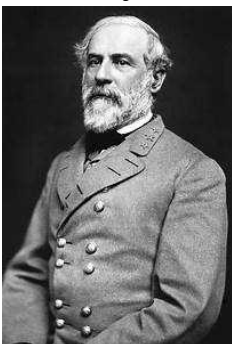
## Theme from our Patriotic Instructor Jeff Smith PCC.

Battle on the Union Right at Gettysburg Union Twelfth Corp. Lee's Intuition is right, Meade Blunders - Three Subordinates fight Lee, Fortune smiles on Meade

*General Lee - Commander of the Army of Northern Virginia*

A missed opportunity on the late afternoon of July 1: Lee: *"Take those hills if practicable"*

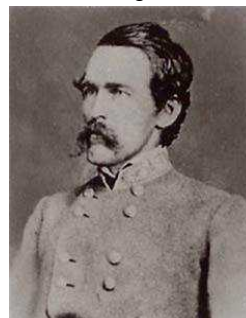
Victory for the confederates on the late afternoon of July 1, 1863 had been achieved, but for the final decisive blow, union troops needed to be driven from cemetery hill and cemetery ridge. Union 11<sup>th</sup> Corp and 1<sup>st</sup> Corp were retreating through town to Cemetery Hill. Lee viewed



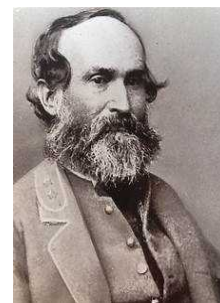
East Cemetery Hill and Culp's Hill from afar and tells General Ewell, "Take those Hills if practicable." At first Ewell, asked Hill if he can assist with his Corp; Hill replied his troops were too exhausted and disorganized from their recent actions. Next Ewell turned to General Early, his division commander and asked if his division could take Cemetery Hill but Early also replied his troops were fatigued and disorganized. Early knew another of his division commanders, General Edward Johnson was approaching, and could perhaps take the heights with his fresh troops. Johnson believes his troops are too far away. The two confederate generals (Early and Johnson) argue; soon the matter is out of their hands; after a couple hours, General Hancock has reorganized 11<sup>th</sup> and 1<sup>st</sup> Corp and they were strongly repositioned on Cemetery Hill and ridge, with several batteries facing the confederates dead - on. Hancock's leadership and confident bearing inspired the union troops. Culp's Hill was still another matter, another opportunity. It could still be taken as night fell, as it was only held by the 7<sup>th</sup> Indiana of Cutlers brigade. A small scouting party of confederates were driven off, with some captured by the 7<sup>th</sup> Indiana. The survivors report this to Ewell, and Ewell decides not to take Culp's Hill that night. Early says that evening to Ewell: *"If you do not go up there tonight, it will cost you 10,000 men to get up there tomorrow!"* Early's prediction of foreboding proved all too true for the confederates over the course of the next two days.

*Three Generals Against Lee! Evening July 1, Ewell's HQ*

Lee rode to Ewell's HQ and met with Generals Ewell, Early, and Rhodes. Lee, knowing the high ground had not been taken, nevertheless, wanted to maintain the initiative and attack early in the morning.

During the meeting, General Ewell mostly allowed Early to speak for him. Early, not a man lacking for self-confidence, told Lee that the ground in their



front was bad for offensive operations (true). In reply Lee said: "Very well then, if you cannot make an attack there, then I had better draw you around to my right." Early again disagreed with Lee. Early, with Rhodes and Ewell in agreement, said it

would be a bad idea to withdraw from their current position for three reasons: 1. Abandonment of our wounded 2. Withdrawing from town would hurt rebel morale 3. Many captured weapons lost by the enemy would be left behind.

Lee left the meeting frustrated. He returned to his HQ on seminary ridge. Without Ewell in action, 1/3 of the rebel army would be inactive, useless to current operations. This was unacceptable, Lee sent a staff officer back to Ewell, with orders for him to bring his Corp back aground to the Confederate right flank. General Ewell was upset by these orders, and rode to Lee's headquarters, and said that He and his division commanders were planning to take Culp's Hill, that very evening. Lee, now encouraged by Ewell's new found initiative and believed Culp's Hill would be the key to driving the Federals off East Cemetery Hill and Cemetery ridge. Lee approved, and allowed Ewell to stay in place on the confederate left.

As we know, the lone but fresh 7<sup>th</sup> Indiana persuaded Ewell not to attack Culp's Hill that night. As darkness grew, General Alpheus Williams Division of twelfth corps came up to supporting distance on union right. The Confederates captured a courier and then knew that 12<sup>th</sup> corps was now very close by to support 1<sup>st</sup> and 11<sup>th</sup> corps troops on the union right. All through the day of July 2<sup>nd</sup>, confederate troops could hear union soldiers building entrenchments on Culp's Hill and all the way to rock creek on the extreme union right. Many confederates were anxious to attack before the entrenchments were completed. Dread grew gradually; as the Rebs heard the constructions proceed.

Confederate Plan B: Await Longstreet's attack on July 2<sup>nd</sup> on the union left and then attack. Ewell will demonstrate and then make an attack in earnest, and seize ground if opportunity affords itself. This is Lees plan B, for Ewell's Corp. But first they must wait; and listen to the federals at earnest work.

*Actions, and Union Initiatives, Morning of July 2<sup>nd</sup>.*



After being ridiculed by his commander (General Geary), General "Pappy" Green, instructed his men to build entrenchments for the brigade. The construction of entrenchments caught fire, as union troops down the whole 12<sup>th</sup> corp. line enthusiastically build them!

General George Meade – Commander of the Army of the Potomac

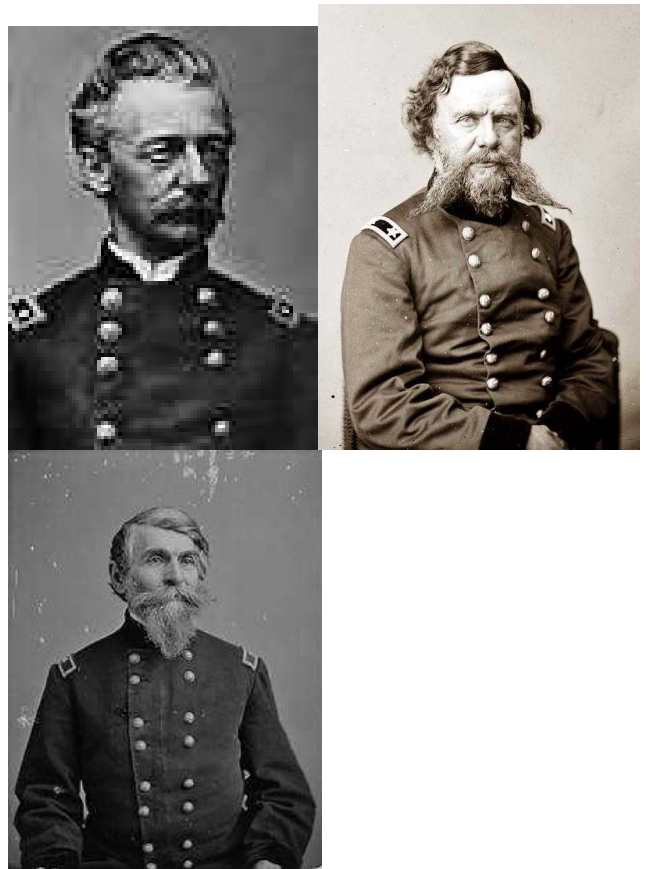
On the morning and afternoon of July 1<sup>st</sup>, General Meade became fixated on the Union Right flank. At first he wanted to make an attack on the confederates, and builds up 12<sup>th</sup> corps, and has arriving 5<sup>th</sup> corps and soon to arrive 6<sup>th</sup> corps to be posted nearby to support attack. Generals Slocum, General Williams, and General Warren (Meade's engineer) told Meade it would be a very bad idea to attack from the union right. The ground is defensive to both sides. Rugged and Rocky, with many trees and swampy ground in parts, the ground on the right flank was perfect for defense. Meade reluctantly agrees, but builds forces on right, as he believes it is on the right that the confederates will attack. Meade ignores Dan Sickles, and the Union Left. Dan Sickles is very concerned. Concerned for three reasons: 1. The Union Cavalry, under Buford, had left (without a cavalry shield on the union left) 2. Sickles sent a probe out directly from his front to locate the confederates; 1st USS sharpshooters and 3<sup>rd</sup> Maine ran into several confederate Alabama regiments form General Marcellus Cadmus Wilcox's brigade. 3. Sickles position is in very low ground, with heavy tree cover directly in his front. Sickles requests for Meade to come out to view his position on the left. Meade refused him, and continues to put his attention on the Union right, where he expects the

rebels to hit. Meade replied to Sickles, "Oh Generals often think it is their position that will be attached!"

Meade called a staff meeting that afternoon. All corps commanders are in attendance but Dan Sickles, who is moving his 3<sup>rd</sup> Corp to the high ground of the Peach Orchard, and anchoring the ends in Devils Den on the left and near the Cordori buildings on the right, along the Emmittsburg road. The 3<sup>rd</sup> Corp line is now stretched 3 times further than the length of a front for which was designed to hold. After noting Sickles's absence, Meade orders him to the meeting, Sickles arrives as the meeting is breaking up, and Meade looks up to Sickles as he rides in, "Don't even get off! I will meet you at your Corps position". In the background, rebel artillery could be heard, slamming the union left. Finally, now the on the union left, and the confederate cannonade had gotten Meade's attention. Meade, his staff, along with General Gouvenear Warren rode toward the Peach Orchard. Meade seeing little round top in the distance, told General Warren to "Check out that Hill". General Warren rode out to Little Round Top and into everlasting fame.

Now the stage of historical fame was set. Just as was the case in the morning, when Meade was fixated with the Union Right; now, as he rode to the Peach orchard, he became fixated with the Union left, giving little thought to the Union right flank on Culp's Hill and its surroundings. Lee had not forgotten it. Indeed, it was part of Lee's plan B, for July 2nd. Put force on the union right flank, after Longstreet's offensive got going, and if a lodgment was made, convert the diversion into a genuine full scale attack.

On the union Right, Generals Henry Slocum, Alpheus Williams, and George Green (Pappy) find themselves and their position forgotten by Meade, just as Dan Sickles and the third Corp. were forgotten throughout the morning and afternoon. However Slocum, Williams, and Green are not men to set passively and dolefully by; they prepare to meet the enemy, and his onslaught they expect to come. They, like Sickles, were men of action, but unlike Sickles, they were professional soldiers, who not only were ready to act, but also had the skill to do so effectively.

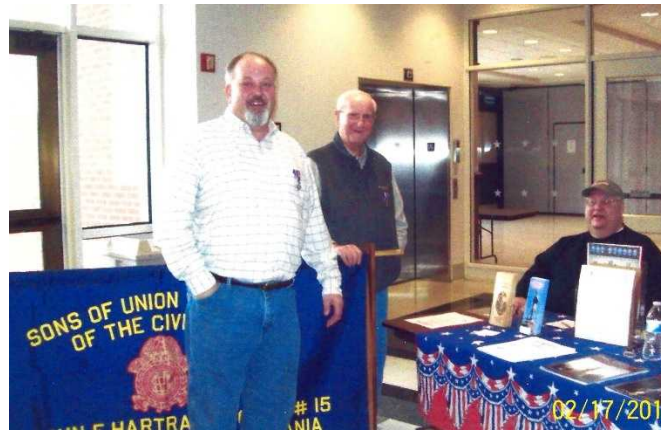

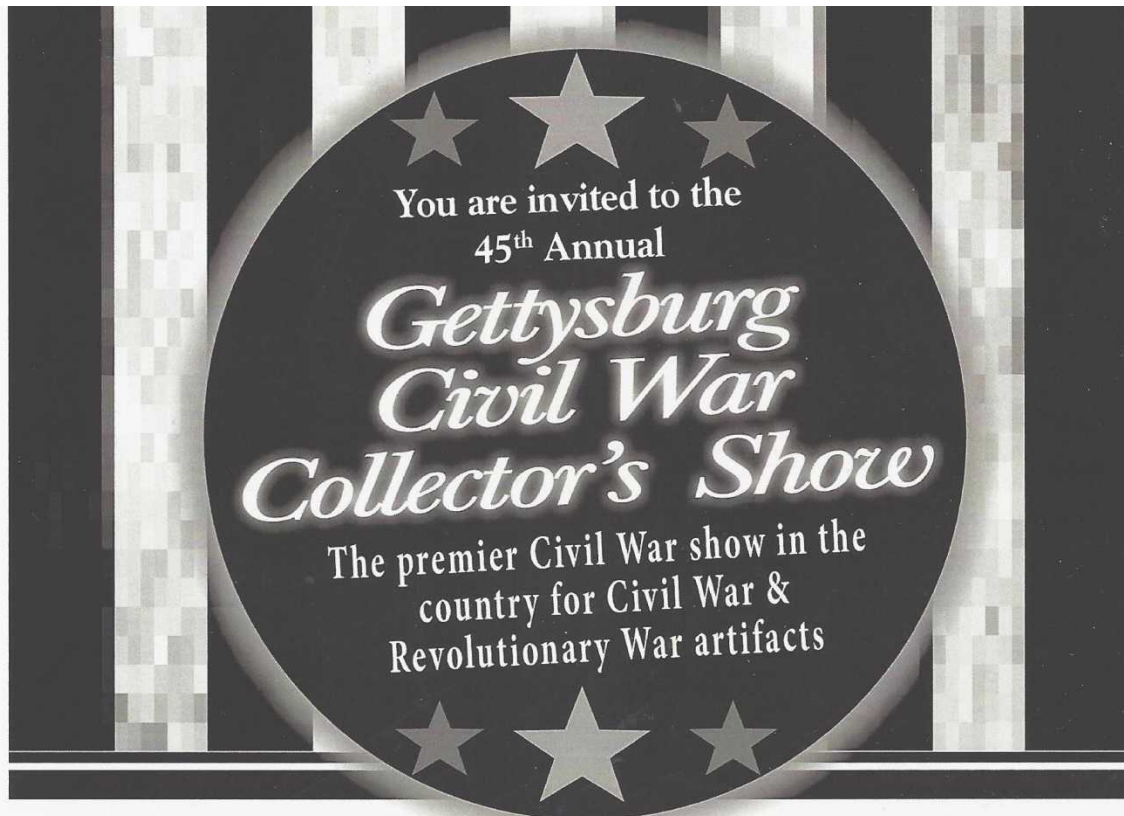

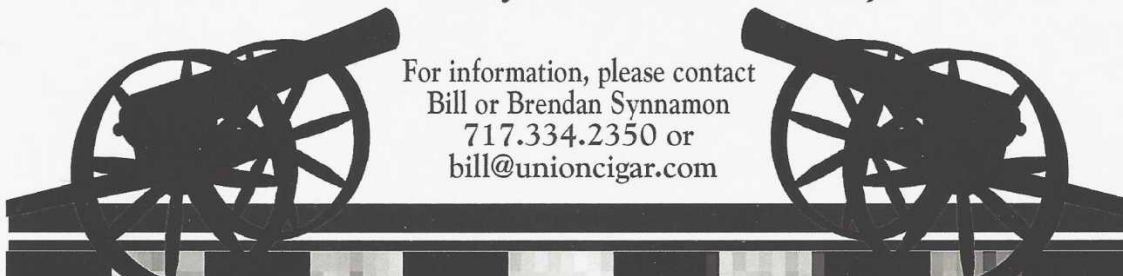
