When you joined the SUVCW with hereditary status, you were only able to designate one ancestor on your application. Now you can honor your other union ancestors with a supplemental application for a mere \$5 fee for each tribute. Use SUVCW form 3, http://www.suvcw.org/wp-

content/uploads/2017/04/Form-3-REV-3-2017.pdf

check supplemental at top of the form. Complete page 1 as usual, input your 2nd ancestor on page 2 and attachment source documentation revealing that ancestor's union service. If you have a 3rd and 4th or more ancestors to honor, repeat the process for each individual. Attach a remittance check payable to National Organization SUVCW, for \$5 for <u>each</u> supplemental *honor* and ship it off to your camp secretary for action.

Upon receipt at Hqs, your computer profile at HQs will be annotated to indicate you have submitted supplemental application data to honor an additional ancestor! Your supplemental submission will be added to your original application hardcopy file! It will be on file at headquarters indefinitely for future generations!

REAL DAUGHTER IRENE TRIPLETT

We have a "Real Daughter" here in the Department of North Carolina and her name is Irene Triplett. Like our SUVCW **Real Sons**, a "Real Daughter" is a woman whose father was a Union veteran of the Civil War. Irene Triplett was born in Wilkes County, NC, on January 9, 1930. When she was born, her



father Moses Triplett, a Union Army veteran, was 83 years old, and her mother Elida was 34. Such *May-December* marriages were *not uncommon*. Many of these marriages took place during the Great Depression, when veterans' pensions offered the wives a reliable source of income, and the veterans got a younger wife who would care for them in their old age. Private Moses Triplett did receive a Union Army pension.

Irene's father, Moses, *Mose*, or "Uncle Mose" Triplett was born in 1846 in Watauga County, NC. Mose Triplett served in both the Confederate and Union Army during the Civil War. At age 16, he enlisted in the 53rd North Carolina Infantry Regiment in May 1862. In January 1863, Pvt. Triplett transferred to the 26th North Carolina Infantry Regiment. In August, 1864, he joined the Union regiment, 3rd North Carolina Mounted Infantry, nicknamed "Kirk's Raiders made up of Union supporters in western North Carolina and eastern Tennessee. Mose Triplett was discharged four months after Lee's surrender at Appomattox Court House, Virginia. In 1938, Mose attended the 75th

anniversary of the Battle of Gettysburg with more than 1,800 veterans from both sides. Moses Triplett died of on July 18, 1938, age 92, days after returning from the Gettysburg reunion. He is buried in an Elk Creek cemetery, and his headstone reads "He was a Civil War soldier."



Today

Irene Triplett lives in a nursing home in Wilkesboro, NC. Irene says that her father didn't talk about the Civil War, and that she doesn't remember too much about him. Irene says that she no longer has any of her father's possessions as they have been lost over the many years since his death in 1938. These days, Irene enjoys watching TV and visiting with the other residents of the nursing home. My wife Denise (ASUVCW) and I travel to Wilkesboro at least twice a year to visit with Irene, bringing her flowers and a gift. ABOVE DENNIS SHOWN WITH REAL DAUGHTER IRENE! Some Interesting Facts About Irene Triplett:

- At age 90, Irene is the last living recipient of VA benefits connected to the Civil War.
- In 2014, the Wall Street Journal did an article about Irene. The reporter, Michael Phillips, who visited Irene, says he is very supportive of the Sons of Union Veterans recognizing and honoring Irene.

- Irene was born into poverty in a tiny log cabin in the mountains surrounded by illegal stills. Irene didn't drink moonshine, but she got hooked on tobacco in the first grade. She still chews tobacco.
- At school, the children would taunt Irene about her father the "traitor", and she dropped out after the sixth grade.
- In 1943, at age 13, Irene and her mother moved into the Wilkes County poorhouse and lived there for 17 years. In 1960, the poorhouse shut down, and Irene and her mother moved to a nursing home, and each month the two would sign their "X" on a VA pension check, which helped pay for their care. Irene lived in the nursing home for more than 50 years until she broke her hip in 2013 and had to move into the Wilkesboro nursing home for additional care.

Finally, President Lincoln, in his second inaugural address called for Americans "to care for him who shall have borne the battle and for his widow and his orphan". President Lincoln's promise is still being delivered today, 150+ years later, to Real Daughter Irene Triplett! In Fraternity, Charity, & Loyalty, Dennis C. 
