Flag not a holy entity, but a symbol of principle

I question the value of any "statement" made by burning the flag, but I agree nonetheless with the Supreme Court's decision regarding flag dese-

I am at odds with those who view the flag itself as a holy entity rather than a symbol of the nation's people and principles. Even Chief Justice Rehnquist, in his dissenting opinion, spoke of dying for the flag, rather than for the ideals or individuals which give that flag meaning. Such an attitude is seen by some as idolatry, and this belief deserves respect.

The British observe moments of national pride with huge explosions of flags; the Union Jack is as powerful a symbol for them as Old Glory is for us, yet they have not felt the need to surround it with regulations. Is our love and understanding of our nation's principles so tenuous that we must cling to the flag as a national security blanket?

have (properly) displayed the flag at home, and I would never deface it, but I shudder to think that a misunderstanding of display protocol might leave me marked as a villain. And I am saddened to think that the Constitution might soon grant more protection to a symbol - however beloved

it may be - than it grants women, the disadvantaged and our environment.

The court's decision does not mean that flag-burning will soon become a national pastime; to the contrary, the explosion of public outrage surrounding this issue demonstrates that it is unnecessary to legislate respect for the flag, and the small class of extremists at whom such legislation would be aimed would be as likely to defy a national ban as they were Texas's ban. While matters of life and death threaten living human beings, legislative action on this matter would be a gross waste of time and effort.

Some readers suggest that public opinion should be weighted in favor of war veterans. Our veterans are peo-ple worthy of respect, but to dole out special privileges to certain people is contrary to the central principle of the Declaration: that rights are inalienable gifts from God and nature, distributed equally among all people. We cannot deny basic freedoms to those we would label thugs and hoodlums because they have offended us. We each have the right to express outrage, but to ask the government to punish those who offend us is

contrary to the principles

which the flag represents.

By denying Joey Johnson his freedom of expression, we would jeopardize our own freedom to express outrage at his actions. That would be a price which I am not willing to pay.

Lift Old Glory to her proper place

Being down in Baltimore this past July 4 weekend, my wife and I had the opportuni-ty to visit Fort McHenry, the place where Francis Scott Key wrote the "Star Spangled Banner" in 1814 on the morning following an all-night bombardment by the British Navy. We watched a short movie about the battle; as it ended a curtain was pulled back and outside waving in the breeze was Old Glory. I could feel the goose bumps rising, also something in my throat and my eyes welling up. It seemed every war we ever fought flashed across my vision as I watched that old

remember when I was small my mother would tell of a song written sometime after

the Civil War. It seems our flag had fallen during a certain battle and the captain called for a volunteer to re-trieve the flag. A young lad brought back the flag but fell under the heavy enemy fire. A general witnessed this act from a nearby ridge and sought out this courageous young man, only to find the dying man was his own son.

I don't believe we should condone this recent act of flag burning, nor should we hate this young man for his actions. But because it took place, I believe more people will rally around her and lift Old Glory to her proper place, a place of honor where we can all look up to her.
